AWIS WOOL MARKET REVIEW

Week Ending 19 May 2023 (Week 46)

The AWEX EMI finished at 1263¢, 21¢ lower (-1.6%) in Australian currency and 28¢ lower (-3.2%) in US currency at sales in Sydney, Melbourne and Fremantle in Week 46.

42,489 bales were on offer nationally, compared with 43,454 bales last sale. There was strong Seller resistance when 15.4% of the offering was passed in after 7.5% of the potential offering was withdrawn prior to sale. 35,940 bales were sold.

AWEX reports that the value of the wool sold was \$50.0 million (\$1,375 per bale), taking the season total to \$2.186 billion (\$1,537 per bale). The number of bales sold at auction this season is now 0.2% greater than in 2021/22.

The market continued the previous week's direction when sales opened in a downward direction across all Merino and Crossbred micron ranges on Tuesday despite a fall in the US Exchange Rate.

The opening falls were followed by further smaller falls on Wednesday and on Thursday (when only Melbourne sold). The overall falls were mostly in the order of 1 to 2%

The US Exchange Rate finished 1.17¢ (-1.7%) lower to close at 66.47¢ on Thursday.

Buyers for China were dominant, with support from buyers for India

Looking ahead, offerings for the coming three sales are expected to range from 29,957 bales to 45,936 bales and to be 4.9% more than in the same period last year. The forecast progressive difference to Week 49 is +0.6%.

In other countries, the South African Cape Wools Indicator was up by 0.1% since last week against a 3.2% appreciation of the Rand against the US Dollar and a 1.9% appreciation against the Euro.

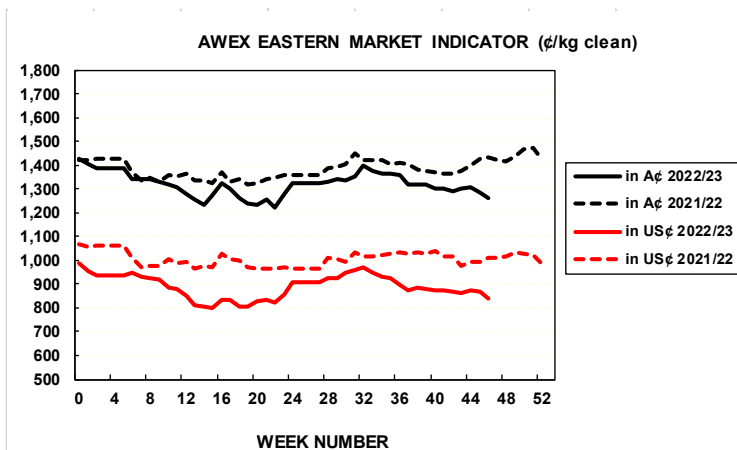

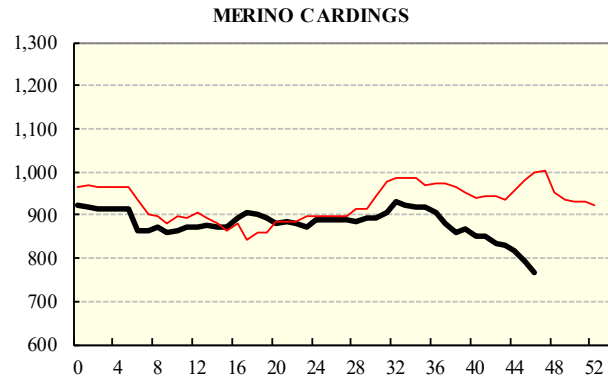
